# Whanau Development

#### Family Start

The Hauraki Family Start Programme is an early intervention and preventative, home based service that works with whanau in the areas of health, welfare and education.

Family Start aims to build whanau strengths by providing support and encouraging positive parenting, to ensure that child/ren have the best possible start in life.

The service is child centered, family focused and strength based.

Family Start is available to:

- · Expectant mothers
- · Whanau with babies under 12 months old
- · Whanau who live in the Hauraki Rohe

# Whanau Support Services

The Whanau Support Service is an intervention, home based service that supports Hauraki whanau and their tamariki by empowering them to work toward health and well being and educational programmes.

Whanau Workers offer support and advocacy:

- · Inform whanau of their rights and entitlements
- Provide and assist whanau to access professional assistance
- Assist whanau to access whanau violence programmes

#### Social Worker in School

The Hauraki Maori Trust Board is involved with Social Workers in Schools. Our social worker works with primary aged children from four schools in the Paeroa District - Karangahake, Tirohia, Paeroa Central, Miller Avenue.

The focus is on children and their whanau during the critical primary school years, in order to positively enhance their learning opportunities, their knowledge, skills, attitudes, beliefs and behaviour. Support to "Build their future"

Our Social Worker offers support and advocacy.

### Tikanga Program

This program draws on Hauraki lwi philosophy values and embodies knowledge, practices, laws and traditions unique to Hauraki whaanui.

The focus is to introduce participants to marae and cultural values in a marae setting who wish to seek a sense of belonging and connection as part of their experience in a cultural awareness journey.

#### Rangatahi Services

The Hauraki Maori Trust Board rangatahi service supports rangatahi to make informed life choices that will increase their level of participation and success in education, sport, cultural indentity, health and social interactions.

The Service aims to build the self confidence and self esteem of Rangatahi to strengthen their networks and deliver individual and peer mentoring.

# Court Managed Care for Hauraki Mokopuna

The Hauraki Maori Trust Board by order of the Family Court receive into its care, Mokopuna of Hauraki, who would otherwise have remained in the custody of Child, Youth and Family Services.

It is our aim to return mokopuna back to Whanau. One of the ways we do this is by strengthening whanau potential, their beliefs and values that will advance the well being of their children.
