INTRODUCING THE BLUEPRINT

This is the strategic plan of the Hauraki Maori Trust Board for the period 2012 to 2017 and was approved in April 2012. It sets out the vision framework and strategic focus for the organization over the next five years.

The strategic plan has emerged from a review of the Strategic Blueprint 2005 – 2013 undertaken by trustees in the preceding years given that the political landscape in Hauraki had changed significantly. Trustees undertook the review of the Strategic Blueprint to ensure that the Board's contribution to the vision remained relevant taking into account the following factors:

TREATY SETTLEMENT NEGOTATIONS – In 2005 the Board planned to lead the treaty settlement process however in 2010 trustees formally withdrew the Board from the treaty settlement process.

FISHERIES AND AQUACULTURE – In 2005 the Board led the process under the Maori Fisheries Act 2004 and Aquaculture Settlement Act to secure the fisheries and aquaculture settlement assets of the lwi of Hauraki. For all intents and purposes this has been achieved and the Pare Hauraki Fishing Trust and Pare Hauraki Asset Holdings Limited, have been formed to govern and manage these assets. The Board continues to provide administrative and financial services to these new organisations.



POST SETTLEMENT GOVERNANCE ENTITY – In 2005 the Board planned to lead a managed transition to and establishment of a post settlement governance entity for the lwi of Hauraki, however with the withdrawal of the Board from the treaty settlement process leading the process is no longer viable although participation in the process will be important.

INTEGRATED DEVELOPMENT – In 2005 the Board was a multi-affaired organisation involved across the spectrum of economic, social, cultural and environmental objectives; however in 2012 the Board's focus is primarily social and cultural.



THE IWI OF HAURAKI

The beneficiaries of the Hauraki Maori Trust Board shall be the descendants of Ngati Hako, Ngati Hei, Ngati Maru, Ngati Paoa, Patukirikiri, Ngati Porou ki Harataunga ki Mataora, Ngati Pukenga ki Waiau, Ngati Rahiri-Tumutumu, Ngai Tai, Ngati Tamatera, Ngati Tara Tokanui, and Ngati Whanaunga collectively referred to as the lwi of Hauraki.
